(("World History Introduction")): In 1918, and on the edge of "World War 1". The Satanic "Zionist-Nazi" movement was implanting the seeds of a heinous great evil in preparation for the annihilation of poor Jews in Europe during the next would be called "World War 2". The "Zionist" criminals with their sick minds were conspiring with the "Nazi's" against their own people, planning would be "The Heinous Crimes of the Holocaust & Gas chambers" as a necessary human sacrifice for their own satanic trinity "False Messiah/Anti-Christ" evil plans to the so-called road map delusions of the promised Holy-land.

Up until the 70s & 80's, when the U.S thought of it self, it can play a dirty double game by using the Muslims for its own cause, interest, and advantage in defeating the Soviet empire, creating would be the Afghani Islamic Jihad (considered terrorism of today), and part of what later became known as the "9/11" jihadist attacks against the U.S, sowing would be the seeds of its own destruction, as a result of its own crimes and aggressions in the Middle east and around the world, not to mention the war crimes, human rights violations, and destruction against Arabs and Muslims during "the 1948 & 1967 Zionist-Nazi-Israeli/Arab-wars", the "1990s Iraq siege & Gulf war, with the "70 years" of massacres in Palestine, Somalia and else where. In the aftermath of "9/11-2001" attacks, the U.S declared a total crusade war on both the Arab and Muslim nations, invading Afghanistan and Iraq under the false fabricated charges of terrorism and weapons of mass destruction, which the U.S it self owns, used and supplied to so many other nations, while "Osama Bin laden" considered his own "Pre 9/11 plans and strategy, as speedy and defensive in preparation for the invasion of Iraq, after the "Bush's family" had won the elections for a second term since the first siege of Iraq, during the past "1990s" Gulf war.

After the end of "World War 1 & 2" with the defeat of the Soviet union. The U.S dominated the world of gangs and criminals around the globe, having a barbaric criminal history of heinous crimes and human rights violations against its own people among "the People of color & Natives Indians, its barbarity spread further more all over the world, with the scandals of "Abu Ghraib, Guantanamo, water boarding, torture, and killing of innocent people, civilians, women, kids and journalists. The Americans became the criminals of the century, killing millions all around the world using nothing except "Nuclear, Chemical and Biological" weapons of mass destruction. First, against smaller countries like "Japan, Vietnam, Korea, and parts of Europe, before shifting toward the Middle-East with the majority of victims in the Islamic and Arab world, with over 5 millions of iraqi's, among hundreds of thousands others in Afghanistan, Yemen, Palestine, Somalia, Iran, Sudan, Pakistan, Egypt, Jordan, Syria, Lebanon, and the list goes on, after the U.S of sick & psycho criminal governance made the Nazi's crimes look like a joke, especially when they lecture the world about human rights, terrorism, and weapons of mass destruction. etc.

Moving on until recent years, "Hosam Al Smadi Story" begun in late of "2008" under the name of "Protective Edge military Operation" part of the Zionist aggression when the Israeli Zionist forces invaded Gaza, killing thousands of civilians, women, and children, using nothings except "American Made" internationally banned weapons of white phosphorus and radioactive munitions to bomb, massacre, burn, and brutally murder thousands of innocent people and civilians, among Arabs and muslims. Finally, as soon the "United Nations" spoken out against the Israeli actions as war crimes and crimes against humanity, "Hosam Al Smadi" became the target of an "FBI Witch Hunt Terrorism Case".

Hosam Al Smadi, born and raised in a large and educated, respected family from the "Middle-East Jordan", He came to America within the hopes of furthering his own future through a higher education in biological sciences, technology and medicine, while also looking to work and establish his own business. Unfortunately for him at that time, "Hosam" moved from California "a more civilized liberal state" to "Dallas Texas" a southern Biblical fanatics state with an uneducated Pro-Zionist majority.

Growing up in Jordan, Hosam became aware of international and global affairs at a very young age after he witnessed the U.S and Israeli aggressions in that region, and as soon he arrived to America, He became another victim of this aggressions, especially after he received from activists, hundreds of war crimes pictures, showing thousands of dead people and civilians, among women, infants, and children, exposing the U.S and Israeli war crimes with their role in the illegal use of internationally banned weapons to massacre thousands. Shocked out of his mind, He made it a duty to expose the crimes and genocides of the war criminals, and bring them to justice with their sympathizers in the federal government, Spreading the horrific pictures on the internet and running his mouth about cyber wars and software tools in an online cyber jihadist chat rooms. The FBI tracked and approached "Hosam Al Smadi" in Texas, before the story Begun:

1-\_(" Details of Hosam Al Smadi entrapment by the FBI gangs")\_. While Hosam Al Smadi was never of any threat, young, revolutionary, and hot blooded innocent mind with high morals and ethics. He at first demonstrated the best of all characters, when he objected to the FBI criminal activity, telling them: " I will not target any women, child or an elder, and several times refused and rejected the FBI's proposed idea's of terrorism targeting civilians and innocent souls, believing in the sacred innocent blood as crime under Islam and heaven it self, mischief on earth, and a great sin that is so horrible and serious in accordance of his Islamic faith, morals, lack of intent, and sense of conscience, that no matter what was the cause, there is no justification for innocent blood, not even war times.

Unlike the Gangs and criminals of the U.S government, Hosam Al Smadi with his pride and heroism had not just mocked the faces of the FBI's gangs and criminals into the ground, but also, He showed them that he was not a scum criminal unto like them-selves, in being cowards colonialist thugs. And, Unlike the coward tradition of the war criminals and gangs of the U.S and Israeli government in the killings of kids and women, Hosam made it clear to them, that he was a man of a true faith, and a true just cause that won't be lost any time soon, even if it was going to lead to his own imprisonment, while standing up against big savages & criminals with big guns.

The very first contact was in (Jan, 2009), when the U.S government, FBI's thugs & agents approached "Hosam Al Smadi" clearly knowing themselves and stating:" They will not seize their tyranny until they are killed, what we need is to "Specify the target", even if two brothers got together, and selected their targets carefully, we will achieve what platoons of brothers failed to do in other countries, and as our elder/Sheikh "Osama bin Laden" has said: Don't consult any one about the killing of an American", make up your mind and proceed by the will of Allah. Bleed their children, women, and civilians as we bleed, eye for an eye, kill them as we are killed, destroy their houses as our houses are destroyed, we want to teach the accursed Americans a lesson, they will never forgets.

Later in (Feb 10, 2009), The FBI dirty agents and gangs violated "Hosam Al Smadi' due process, by providing him with a fabricated Jihadist materials of Islamic warfare and justification, as an Islamic (fatwa) edict so they can brain wash and psychologically coerce him and his faith into the U.S government terrorist plot, materials that encourage violent and justifies the killings of civilians and innocents, under the notion of eye for an eye in accordance of the Qur'anic and old testament Torah laws, promising "Hosam Al Smadi" much of heavenly, spiritualistic and materialistic rewards. The gangs of the FBI's and corrupt government agents gave "Hosam" documents called "Burhami's Jurisdictions of Jihad" in attempt to make Smadi carry a terrorist attack against American civilians, after Smadi refused several times. In (Feb 2009): Smadi told the agents that he saw a dream, alone and defenseless in a village to meet a young man with a short beard, it was Prophet Jesus, among other prophets, Moses, Muhammad, Joseph and King Solomon.

In (March 9, 2009): The FBI agents told Smadi, we are trying to get you to meet Osama, but Osama want you to stay in America, because there are many Mujahedeen in the battle field, but few behind the enemies line. Subduing the infidels in their own homes is better. Smadi response" I don't want to do any thing that is dangerous, or harm any innocent".

In "(March 13, 2009): Again Hosam Al Smadi refused the FBI orders, and told them It was forbidden in Islam to kill the innocent and peaceful satisfied souls; this means women, children, elderly, civilians, and those who didn't kill Muslims. Further, Smadi tried to get out of the situation by making lies on the government, that he can't do Jihad with out of his parents permission, and he was not a good Muslim, because he is been seduced by the devil into many bad deeds and sins, because it was the end of times apocalypse and the Antichrist, Gog and Magog were coming, I am not very knowledgeable in the religion, you are my teacher.

In (March 18, 2009): The FBI government agents suspended the mission, because Smadi won't go ahead and was not a threat to the U.S public and citizens. However, the head of the FBI ordered his agents to coerce and manipulate Smadi into a false terrorism case, for prosecution.

"FBI special agent in Dallas field office: "Carlos Ortiz Jr." noted that, the head of the FBI at that time "Robert E. Casey" ordered his agents to target, coerce and manipulate "Hosam AI Smadi" in a terrorist attack, because of his faith and for the reason of political motivations, the whole tactics were used are illegal. Smadi was an 18 years old, young guy, who was targeted because of his faith and for political reasons. He was very easy to be manipulated, most of evidence in this case were illegal, the head of the FBI was corrupt, and abusive.

One year later, after the false arrest and prosecution of "Hosam Al Smadi" by the dirty and corrupt government agents. The head of the FBI was terminated for having being accused of corruption, sexual advances and misconduct. "FBI special agent Carlos Ortiz Jr. too" was fired and prosecuted on charges of corruption, attempted to murder the head of the "FBI", spousal abuse of his wife, history of violence and addiction, his wife too was an intelligent analysis who worked on Hosam Al Smadi Case.

During the on going dirty scheme, the U.S Gov applied psychological coercion on Hosam Al Smadi from (Jan -to- April 2009): For example: "the FBI agents pretended to have fought with Osama, they tried to prepare him with training, and encourage "Hosam" to join Jihad for martyrdom because it was the essence of Islam.

The government: "you are on the right path, forgiveness for all your sins and transgressions, don't care about your parents permission to do any thing, listen to God not to your parents, we don't have any time, you need to decide right now.. the government begun putting psychological pressures, trying to impose their will on "Hosam". During the case, the FBI agents applied so much pressure and coercion during the months that led to "Hosam" false prosecution.

The government: "We will take care of your parents, and family, \$\$ money is not a problem, we're rich bro's are here to help, we need to prepare your training and protect from those who raped our woman's and invaded our lands to kill our children...etc,

The government: "Let us share a prayers with you to defeat the tyrants, the zionist, the jews and christians, to liberate the lands, and free the people. We can supply you with any thing needed, we need to give them a devastating attack, God placed you in an ideal location "Dallas Texas", as you will be among many brothers, and a part of an important mission, that will shake the whole world.

(2)- (Illegal surveillance against Americans, Part of the U.S government misconduct and duress). In around (March 2009), the FBI were conducting illegal surveillance with the help of the "NSA" against "Hosam" and his American citizens friends, harassing him under duress in his resident, listening to his phone, they attacked a meeting where "Hosam and his friends meets to party". They attacked and arrested his friends, and seized a huge load of drugs. "Hosam" begun having troubles and is under threats for being an undercover suspect, under duress he tells his friends that he was involved in a conspiracy with some U.S government agency, that was involved in the 9/11 attacks, and they are watching and trying to coerce him into a trap of a terrorist attack.

\*More Psychological Coercing": In (April 22, 2009), The FBI agents invited Smadi to an out side restaurant on a lunch to eat Stakes and eggs, they lectured "Hosam" about the harm of pork, and tried to anger him about the death of innocent civilians in

Iraq and Palestine. Then the agents brought him some cigarettes to smoke, and told him that If he does this, and follow the orders. He will become rich in this life, will be given a nice sport "B.M.W 2009", and will be going to heaven with his family. Hosam was told that this \$40.000 dollars BMW, will only cost him \$10.000 Dollars, only if Hosam agreed to follow the orders.

While Hosam showed some declined, He told the agent that he does not want to go to Guantanamo, He had a bad dream and was effected after the siege of Iraq, and there is something evil trying to destroy his life.

The government told him: This is the devil, don't worry about money, don't worry about anything, do you know how to do any thing for this operation, medicine, weapons, any thing at all.? Smadi say: I know how to use a kitchen knife, what a joke! Note: "nothing about bombs".

Smadi told the agent: I only decided to do something after I met you. For the money deal, the Bmw, and to have a chance to see Osama bin laden as you promised.

On (April, 24 and 25, 2009), government told Smadi that Osama bin laden, and Prophet Muhammad will be proud of him, and promise to buy a new gift "laptop computer".

("FBI Zaid"): a vital point in Hosam life was his parent death to cancer, experiencing some "Anger displacement", to cope with his lost, not extremist, delusional about Iraq siege, end of times, the Antichrist, return of Jesus, the Islamic and caliphate apocalypse.

On May 9, ("FBI Behaviorist and psychologist"): Advocates change in approach, the government agent was acting as a leader to manipulate "Hosam", the agents should act as facilitators than leaders.

On (May 12, 2009): The informant invites Smadi again for a meeting in the Embassy suit hotel, he tries to motivate Smadi into a terrorist act, the government agent try to push Smadi to pick a target in Dallas downtown. It was the government who mention Dallas as the target. Also the government promised a better job that pay over \$15-25 dollars in hour.

However, Smadi was shocked never set his mind on any thing yet. He say he would be a normal American if he had not met the government agent.

Again On (May 14 "FBI Behaviorist and Psych"): They advice that Smadi was too young for manipulations, they're not sure if Smadi was an actual threat, partying with drugs, and whether he even have the mind set to make any act. They also notes that he is vulnerable, susceptible to recruitment and manipulation, not very religious, and had done little to make any thing happen.

Between "May - June" of 2009, Agents tried to psychologically pressure and coerce Smadi into making a terrorist act to harm innocent civilians, or even pick a target. Smadi always refused, and tried to tell them to go to some oil field, because Smadi intent was to try do something away from people to protect the innocents.

However, the government agent dissuades him and tells him, that this was difficult. "There are things that are doable and others that are not". Again, the government agents manipulated Smadi and told him. Don't worry about the money deal, Don't worry about any thing, we're your brothers.

In Between ( "April", and "September 2009" ): The FBI begun taking "Hosam Al-Smadi", driving out on a ride inside the FBI car, to inspires chains of events that other wise would not happen or occur. It was the practice of the government agents, to make sure that Smadi only traveled inside the FBI Car with them. This was done in an effort to Produce the "Surveillance" that the F.B.I wanted rather than to record events as they might otherwise occur. In fact most of Surveillance in this case came from governments leadership and inspired planning, rather than Smadi own will and pure intent.

The agents met with Hosam in Dallas Embassy suits hotels for over "5 times in ("April, May, June, July, and August of 2009"). They took Smadi to out side restaurants for about 3 times, ordered him hookah, smoke and cigarettes. They told him about a better job that pay about \$25 dollars in hour, and promised to get him the \$40,000 dollars sport BMW. The biggest promise of all is to have a special meeting with "Osama bin laden" just to make Smadi go along with their plans of manufacturing terrorism cases.

The agents went as far to make "Hosam Al Smadi" go to Desoto Dallas Mosque in attempt to target and recruit innocent Muslims for prosecution. The FBI agents attempted to pay Smadi about a "\$100,000" dollars in cash, if he go and recruit innocent Muslims and much fun for international travel. The FBI agents even tried to make Smadi move to "Newyork", for a new job of learning and training lessons, on how to make bombs and explosives. Smadi refused the government terrorism job and found excuses, because he had no intent and no desire to do any thing with bombs against innocent people.

In (June 15, 2009) The government agent praises Smadi as the hero lion of Jordan high mountains, talks about revenge for the religion, the widows, the orphans, and the disfigured, and praises attacks happen in little rock.

In (June, 24, 2009), While riding with FBI agents. Smadi is told to only follow the orders. The orders that are going to come, whatever we receive. I will tell you, "Okay do such a thing, This is what I will do. "Hosam", understood not to make any decision of his own, and to follow the orders, plans and leadership of the government terrorist organization. This act is illegal violation of the law, to frame up is government creative criminal activity.

The agents identifies themselves as family figures who cares about Smadi. However, Smadi tried to impress them by saying all the bad fantasy, and says he is happy and proud to be one of their hands, do as they please and advice. "Hosam" tried to make excuses that he can't do any thing, yet, the government agents are the ones who makes no excuses are accepted for their own terror plans.

In ( June 24, 2009): The FBI agents took Smadi out on a trip inside the FBI car and identified two targets. Dallas Lovefield Airport, Dallas National Armory, and a Recruiting Center. Smadi backed up, and made some excuses for the agent to change the plan, after he tried to make Smadi wear a suicide bomber vest, and take a bag of explosives inside both targets.

In (June/24/2009): Smadi exchanged cars with his neighbor "Guillermo Rodriguez", to survey and meet the FBI agents while in disguise. The FBI took "Rodriguez" car license number and gave him a visit, with an informant prostitute to frame him up in a false case, but he discovered the trap and refused to cooperate, because Smadi, has already warned "Rodriguez" about a government agency conspiracy, after he brought him some beer and whiskey on that day.

See legal case in Dallas Court:

Rodriguez ID# 1679572 v. Bentley, Lexis 46202, (5th Cir 2013). Rodriguez now is serving a life sentence in a Texas state prison after a frame up false case of Illegal surveillance.

During the month of July 2009, The FBI agents tried to pressure Smadi, for morethan 3 times to make terrorist attacks in America. Smadi refused and said': I don't know, that's why I wanted to ask you from the beginning, I am puzzled and confused. Smadi had no intent and never decided prior to meeting the government agents, after inducement, psychological coercion and manipulation playing on his weakness.

Later on, the agents invited Smadi" to the embassy suits hotel for a big surprise, a gift to make a video allegiance for "Osama bin laden", while also wearing a desert style garb to cover up the face. Smadi does not want to do this crazy thing, but the agent

insisted. Unable to produce the video, the agent took Smadi back to his resident, to calm him down, relax and find a transcript from the internet to do the acting later on.

Smadi went back and smoked some weed to calm down. But Later, something ridiculous and funny happens, while trying to make the video, Smadi face was covered up with the desert garb, instead of hiding his identity, he starts the video by saying "I am Hosam As-Smadi in America"... It was hilarious that the agents are trying to cover up Smadi face, while Smadi is exposing his own identity because he was high.

Later, The FBI took Smadi driving inside the FBI car, going into Downtown Dallas, a trap part of the government practice in producing the surveillance false evidence, and in attempt to identifies something, after Smadi failed to go any step further to make the terrorist act happens.

The agents stops in downtown Dallas, and tells Smadi to go check Fountain Place, Big Banks, Law enforcement, Energy, Credit Cards and Financial Federal buildings. This was the first time in Smadi life that he goes to Dallas downtown, and because he lacked the intent, Smadi came back to his senses having reservations about violence, because there are children and innocents people.

'Smadi: I was not sure, like you say, there are many people who have just come to withdraw money, you know. The "FBI" Agent: Yeah. "Smadi": I don't know, there are some children in the cafeteria, there are restaurants under the Bank. The agent: Yeah. "Smadi: I don't know by God.

The FBI agent: "Casualties will be good. Smadi tried to change the plan and not to go ahead. The FBI agent rejected that effort:" We want Casualties, it will be good thanks God. This target location is right and good, bring down building on their heads, we're brothers.

Weeks later ("August/9/"): Smadi still doesn't want to harm innocents in the FBI terrorist plot: "I discovered that the building has families and some children. That's why I am hesitating. There are innocent people such as children and senior people there. That's why I don't want their souls to be a sin on me. That is why lets go for other plans, "The decision will be yours". The government leadership.?

Note: It was never Smadi will in nay thing, rather "its the FBI agents leadership, decision and will over Smadi, after they psychologically coerced him into their own illegal and criminal creative activity."

On (August/14/ ): "Smadi doesn't want to decide and wants to put it off, because he lacks the intent and the mind set for the FBI terrorist attack. "I ask you to be patient and give me your orders and opinion... What is your orders and plans, we should not do it.

The FBI agents responded with praise to Smadi, as a courage's, creative, worthy of praise. (The new Sultan Saladin), go ahead because this will help in the afterlife, ignores plea to wait, we need to rush. The FBI puts pressures on Smadi to go ahead manipulating his faith; This will be good deeds in your balance on the day of judgment, there is indication from God the Almighty that you will contribute to the victory of our religion, our cause, and the expelling of the tyrant from Muslims land just as your model "Saladin" did before during the middle age crusade times.

FBI agents: My brother, the time to hit the enemy in his very own home with hurting and repeated attacks is getting close, all the leaders of the mujahedeen are waiting for you. I was happy when I read your last message, the one before last, that you observed the "existence of people, families and innocent children in the identified targets, and that you "attempted to avoid such casualties. This indicates your maturity, and you're following the example of the prophet. Therefore my dear, please explain to me what your understanding, and what your expectations are about the casualties on the forthcoming victory day.

Also, to manipulate Smadi, they say don't be scared because the operation is not martyrdom. The FBI encourage Smadi ("Osama bin laden") is going to mention an upcoming video recording. He is waiting for you to follow the orders.

On (August/26): The agents invited Smadi to the embassy suits Hotel, to eat and brake his Ramadan fasting. The agents brought Smadi sheesh kebab, Humus, Falafel, Sweets..etc Smadi brought the informant chocolate almonds, and embroiled knife." The government agents plan their own crime through creative criminal activity. They engaged Smadi about what type of equipment would be used. However, Smadi blow them all out after he tried to withdraw. Smadi told them: "I don't know any type of materials or equipment.

The agents plan the crime seeds, fruits of the poisons tree, and they comes up with the ("Idea, Type and Amount of the

Explosives would be used"), to "Park a car loaded with large amount of explosives", to increase Smadi charged indictment, sentence, and to make the offense looks more serious. The FBI agents told Smadi to write the instructions with an Email. Smadi understood to follow the orders".

The FBI said: ("The explosives are "500 Pounds of C-4, "Military grade explosives, Taliban style car Bomb to get more explosives"). Smadi tried to change the idea, and use a backpack in a restroom toilet to avoid any harm to innocent people. FBI agent rejected that and took Smadi to Dallas in the FBI car to produce more Surveillance, they took Smadi to where they would park the alleged car bomb, financed, inspired and made by the FBI.

Smadi confused and say: it will be an experiment, and that he doesn't want to harm innocent people, so lets do it on the weekdays, because there are too many innocent families on weekend. The Agent tells him, that they are brothers. We love you as brother and a son, you will help many of the oppressed Muslims in prisons and war, place smiles on their faces and wipe their tears. Smadi to set up the FBI agents with the Car bomb terrorist attack: By God you all are as my family and brothers, more precious to me than my blood." Smadi told the FBI to sets up the date, not him.

On (29, August): Smadi told the FBI agents that ("Osama bin laden") up-coming video recording must declare the operation accomplishment by the help and assistance of the U.S government, military and their families who hate the lying corrupt government, its politics, failing domestic and foreign policies, and want to revenge for their children. Also, release all war prisoners, free Palestine, withdrawal all troops and stop the aggression against Muslims.

On (9/11/09): Smadi was smoking weed with his girlfriend. He was arrested by Ennis county police. The police told Smadi he was on the terrorism watch list. Smadi went to jail and was to be turned to immigration as an illegal immigrant, driving with no insurance or license. Smadi was told by the police that the "FBI" intervened for his release. On (Sept 24 2009): The FBI picked Smadi in Dallas, they show him where to park, about 300 meters in a circle. They gave Smadi some cash with a parking fee for the FBI car bomb, and placed an FBI phone in his pocket. Later, they attacked and arrested him after they knock him out. Smadi was taken into an "FBI" secret investigation room. what did Smadi do at last? Surprise!

Smadi confessed on the government terrorist cell and on the truck bomb location under fountain place in downtown Dallas. The FBI attempted to fabricate the crime scene, move Smadi car, lie about foiling a plot, hide the confession video, most of the false evidence, and blame Smadi and Al Qaeda on international TV, before he exposed them.

I was so relieved and happy that I got their full confession on the bomb materials, and that nothing happen to innocent people. I then, went ahead and signed up an authorization for the FBI to contact my country "Jordan", to tell them that I have been arrested a part of an alleged bomb and terrorist plot. I stayed silent, and kept every thing secret, until I can expose them in the court hearings later, and so I can be safe.

However at last, I made reverse psychology and ended up the FBI investigation like this: "Oh please "don't put me on TV, "Please don't tell any one about me, and the alleged car bomb, Please don't say any thing to the international media, if my family and dad's see's me on TV he will have a heart attack. LOL, I done all of this, so I can make the stupid government agents, and the FBI publicize my arrest with their lies on international TV, about how they foiled the plot, and stop an alleged car bomb from exploding, so I can expose them later that they are the corrupt criminals, with a government made bomb, and secret terrorist cells activity. It worked, I was all over international TV with the U.S government and FBI's lies.

((( "What was my Message, that I was screaming in the investigation room, and was trying to send "...???? \*)):
"It was that the FBI and U.S government are involved in terrorism, and in this so called foiled attack, as happened in the Oklahoma bombings, the 9/11 attacks, and I got them confessing on the bomb materials under the camera, using reverse psychology on the idiots, corrupt thugs of the FBI.

## 3-\_(Courts Proceedings and Prison times)\_\_:

During so called fake trial, I was held and tortured in solitary confinement inside an isolation (10ft X 10ft) box, for over 700 days. This was done in an effort to cause me psychological and physical trauma, to make me enter into a false plea under duress, and to isolate my communications, to make sure that I will not be communicating with any media to expose the corrupt and dirty FBI thugs role in the terrorist attack.

During courts hearings, my public defenders lied to me, so they can get my signature on a protective order for the government dirty evidence, "thousands of falsified mirrored copies" was made from a government email and government computer hard

drives, so they can cover up and hide every thing, including the names of the FBI terrorist thugs. My fake public defender government lawyers told me, that if I signed on the protective order, I would be going home. However Later, after I signed on the so called legal protective order.

I was tricked, my lawyers begun acting prejudice to me, telling me that I was not going home, after I wrote a letter to "Dallas Morning News Paper" exposing the government and informing the public that the U.S government actually lied, and they had put and manufactured a total of "500 Pounds of dangerous C-4 explosives" inside a government truck to make it look like Al Qaeda foiled plot.

The "Dallas Morning News" brought this paper to my sentencing Judge "Barbara M G Lynn" who advised me to go to trial, and that the government might have no evidence against me, after they made so much lies on the public and international TV. Unfortunately for me, after so much torture, fake court cinema and theater, my fake lawyers were conspiring with the U.S government to cover up all the lies and corruption in my case, then blame me on international Tv, after I got the government terrorist cell into real good set-up, making them confessing under the camera about all the explosives materials they have manufactured and try to say it was fake later.



In CMU Terre Haute hell. I was harassed, stripped naked, assaulted, tortured, and abused. I went into several hunger strikes, which caused me health damage and trauma. I stayed for over 5 years into hell over there, where BOP guards fabricated reports, threw mail, abused inmates, and then make fun about it, worse than Guantanamo, or Abu Ghraib.

I spent hundreds of days in Shu times, I will never forget how after I had my hernia surgery, they put me into a small and filthy Hot box of over (120' Fahrenheit's degree) in the middle of the summer with closed windows, cockroaches running wild every where, before being subjected to ear splitting, loud noise that caused me sleep deprivations, part of the southern evangelical and biblical fanatic scheme in torture. I was forced into attempting to hang my self as a way to end torture and move to hospital.

Now, I moved to Marion, where I experienced some harassments, and obstruction of communications, compare with Terre Haute, I am in a lesser Hell. Still fighting my legal case, I am far away from receiving any justice by the American corrupt and dirty system that have been executing and framing thousands of innocent people, for the past 200 years. All the falsified evidence in my case are sealed under Classified protective order until "2036" to cover up the lies, crimes and corruption of the FBI.
